Since it was founded in 1965, Fight for Sight has become the UK's largest charitable funder of research into the causes of and cures for sight loss. Our achievements range from saving the sight of countless premature babies to leading the world on genetic research which is restoring sight in young people fighting hereditary blindness. However, with so many people around the world living with sight loss and an ever-aging population, there is much, much more to do.

In half a century the world of science and technology has changed beyond recognition. The scientists we fund today are doing work our founder could never have dreamt of and we are on the cusp of amazing breakthroughs that have the potential to change the lives of millions of people worldwide.

What we do

Fight for Sight is the leading UK charity dedicated to stopping sight loss through pioneering research.

Our vision is simple. We believe in a future everyone can see. It is estimated that there are two million people in the UK living with sight loss that affects their daily lives. For half of these people, their sight loss is avoidable, primarily by getting an eye test and a prescription for glasses or contact lenses. For the other half it is not so straightforward. There are hundreds of eye diseases and conditions that cause sight loss that we cannot currently prevent, treat or reverse. Sight loss has devastating consequences – for individuals, for families and, as the numbers grow ever larger, for our health and social care infrastructure. Sight loss is one of the biggest health challenges we face as a country.

Our goal to stop sight loss caused by eye conditions and diseases relies on us funding the highest quality research, maximising the impact of the information we provide to the general public, influencing opinion and shaping policy.

We have three main strategic goals:

- To provide our stakeholders with the information they need based on our expertise in eye research.
- To bring forward the end of sight loss by investing in and promoting research.
- To be a voice for people with sight loss, using our influence to drive change.

This is an incredibly exciting time to be involved with the organisation as we look to an exciting year ahead in 2020. We are currently half way through a five-year strategy taking us up to 2022. A recent mid-point review recognises that we work in a challenging environment, but our ambition is undimmed. Eye research is significantly underfunded in comparison to the number of people affected and, as the largest charitable funder of research into sight loss, we know we are uniquely placed to influence that. In 2020 we will publish a crucial research report that will give us the evidence base to help us transform the eye research landscape.

Making it happen

Fight for Sight's primary way of delivering its goals is through funding the highest quality medical research. We enhance our impact by considering new and innovative solutions for patients, providing information, influencing opinion and shaping policy. Where possible, we work collaboratively to develop innovative partnerships to maximise opportunities to meet our long-term goals.





Our research, which is subject to the most rigorous peer review system, is organised and distributed across four main programme areas:


- Age-related macular degeneration
- Glaucoma
- Inherited eye diseases
- Sight loss linked to other diseases (Multi-morbidities)

Our work receives no statutory funding; we fundraise for every penny we invest in research. This investment is a direct result of the generosity of our amazing supporters, many of whom have first-hand experience of sight loss and are determined to be involved in the fight against sight loss. As a result they donate, they fundraise and they help raise our profile in their communities.

Context



Committee Structure

I am the Commercial Director of digital agency group Draw, and I bring 25 years' experience of leading commercial and communications activities. I have worked both client and agency side and have owned and managed successful companies including Flint London, which co-ran the non-accredited media centre for the London 2012 Olympic and Paralympic Games. I am also a school governor and a Trustee of the Barfil Charitable Trust. I joined the Fight for Sight Board in 2017.

I am an internationally experienced life sciences lawyer and expert in providing legal advice to the pharmaceutical, biotech and food manufacturing industries. Professor M Francesca Cordeiro

Member of Research, Policy & Innovation Committee

I have been a Trustee for Fight for Sight for over three years. I am a clinician-scientist, Professor of Ophthalmology at Imperial College London, UCL Professor of Glaucoma and Retinal Neurodegeneration, Consultant Ophthalmologist/Research Lead and Director of the ICORG Clinical Trials Unit at the Western Eye Hospital London. I am passionate about eye research and have been developing novel and translational treatments and diagnostics in retinal neurodegenerative diseases, including glaucoma, AMD, Alzheimer's, Parkinson's and diabetes, for over 25 years, with a target of saving sight and reducing disability. I have been fortunate in received a number of international awards for this work, most recently the 2019 Duke Elder Award from the Royal College of Ophthalmologists, but recognise that there should be much more funding for eye research, which is why I joined Fight for Sight, to promote and support this cause.



Simon Craddock

I became a trustee of Fight For Sight in 2016. My career in public relations and marketing started in 1989 and has given me the experience of working in marketing communications in over 85 countries. Over the last 30 years I have worked for consulting firms, for start-ups and for large corporates; including five years as communications director for Motorola Solutions. I am currently the chief marketing officer of a private equity backed manufacturing company based on England's south coast. I have personally seen the often devasting impact that sight loss can have on an individual and their loved ones. Professor Roy Quinlan BSc PhD

Member of Research, Policy & Innovation Committee

I am a Professor of Biomedical Sciences at the University of Durham. My research interests are the biological processes that cause human disease – because whether it is eye lens cataract, corneal dystrophy or macular degeneration, the underlying biological processes such as cell division, maintaining cellular equilibrium and dealing with physical, chemical or environmental stresses when cells are young or when they are old are common to all and contribute to the development of disease. Eye Research has championed many medical breakthroughs (e.g. transplantation, cancer treatment and gene therapy) demonstrating that its impact reaches far beyond just ophthalmology. Lens cataract was also the first ever disease identified to be inherited in humans – arguably one of the greatest contributions to biology and clinical science. My own work concerns the link between form and function, for which the eye lens is a super paradigm. I have been associated with the charity for over 25 years – first as a researcher supported by the Charity, but most recently as a trustee since 2015. I give my time, experience and knowledge back to our charity to help it continue to support eye research in the UK and encourage the next generation of interdisciplinary clinical and academic researchers in this currently very challenging funding environment.

Professor David Spalton FRCS FRCP FRCOphth

Member of Research, Policy & Innovation Committee and Marketing & Fundraising Committee

I joined the Board of Fight for Sight about seven years ago because I wanted to promote eye research. I trained at Moorfields then became a consultant at St Thomas' Hospital where I established a special interest in patients with complex cataract problems and did a lot of research on the design of the intraocular lens which has lead to better lens designs and my appointment as a Professor of Kings College London. In 1984 I wrote a textbook 'The Atlas of Clinical Ophthalmology' which won the prize for the best year for the first and third editions, a unique feat in medical publishing and has gone on to be translated into 10 languages. I served as President both of the United Kingdom and Ireland Society of Cataract and Refractive Surgeons and the European Society of Cataract and Refractive Surgeons. I have retired now from clinical practice but ophthalmology still takes up the majority of my time and I look back on my career with enormous pleasure - if I was doing it again I would do it again. Otherwise outside work I enjoy gardening and fly fishing.

Louisa Vincent

Member of Finance & Resources Committee

I joined Fight for Sight as a trustee and member of the Finance & Resources Committee in 2015, having had around 25 years of business development and relationship management in the funds management and pension sectors in the UK and Australia. Most recently I spent 11 years as a managing director with Lazard Asset Management in London where I had overall responsibility for its institutional clients across the UK, Benelux, Nordics and the Gulf, before leaving in 2018 to build a portfolio of independent NED roles. I chair Fight for Sight's Data Protection Committee and an active member of the Speakers for Schools network. Jenny Williams

I joined the Fight for Sight Board in 2016. I had recently stepped down as CEO of the British Gambling Commission, after over a decade regulating lotteries and commercial gambling. I was also one of the founding board members of the (charitable) Fundraising Regulator. Before my appointment to set up and lead the Gambling Commission, I had had a range of senior civil service policy and management posts in various departments including Environment, Transport, Inland Revenue and the Lord Chancellor's Department. I had been a trustee of a homelessness and of an adult education charity. My father's struggles with macular degeneration made me acutely aware of the need for eye research and keen to use my governance, policy and regulatory experience to support Fight for Sight in finding ways to prevent or treat sight loss.



ROLE SUMMARY

TERMS OF APPOINTMENT

The term of office is three years. Re-appointment for a second term will be subject to a review and approval by the Board. Time commitment can vary but the role of Chair requires approximately two days per month. There are four board meetings a year plus the potential to hold one or more strategy 'away days'. The Chair will also occasionally attend events and meetings as agreed on an ongoing basis. The Chair will also be expected to meet with the Chief Executive to discuss priorities, operational challenges, and the Board agenda etc. This is an unpaid, voluntary appointment, but expenses will be paid.
