About us

The Burdett Trust for Nursing (the Trust) has supported the nursing contribution to healthcare for over 20 years and is the largest funder of nurse-led projects in the UK. The Trust has awarded grants of more than £59 million since 2002 and has an investment portfolio of around £90 million.

The Trust strives to support nurse-led projects that empower nurses to make significant improvements to the patient care environment. Burdett is an agent for change and focuses its funding on innovation, transformation and sustainability in the following key areas:

- **Research:** prioritising academic rigour, data-driven technology and the collection, analysis and evaluation of empirical nursing data to guide and enhance health policy development.
- **Leadership:** ensuring that nurses are represented and influential in the decision-making and formulation of health policy and that they contribute to the effectiveness of health and social care systems.
- **Recruitment and retention:** investing in sustainable improvements into the recruitment, employment, development and retention of world class nurses with shared vision and values.
- Education and training: preparing nurses to work effectively in interprofessional teams, maximising their clinical skills and competencies in health technology, with particular focus on the deployment of applied skills to a range of health and social care settings and client groups, with particular focus on primary prevention and local population health and to improve healthcare outcomes.
- **Health advocacy:** supporting nurses in their provision of holistic, patient-centred care to respond to the needs of the individual, preventing and managing non-communicable diseases and facilitating the effective integration of health and social care systems.
- **Diversity, inclusivity and wellbeing**: supporting policies that ensure diversity, inclusivity, equality, anti-racism and gender-sensitivity in the nursing workforce and policies that address violence, sexual harassment, discrimination, liberty, protection and safeguarding.
- **Global workforce:** strengthening the global nursing workforce by championing improvements to working conditions, safe staffing levels, fair pay, health and safety and a standardised system of nursing credentials and effective leadership.

The Trust is governed by a board of voluntary trustees. They bring specialist knowledge from a wide range of backgrounds. To maximise the impact of our funding, the Trustees have appointed 'funding partners' to work with them to deliver carefully targeted grant programmes and nurse-led initiatives. The projects are monitored to ensure they achieve positive outcomes for patients, nursing and healthcare practice.

The Trust also funds the Junius S. Morgan Benevolent Fund which provides hardship grants to current and retired nurses, midwives and nursing associates living in the UK. Since the Fund's inception it has made thousands of grants to members of the nursing profession to help them when they have needed it the most.

In 2018 and 2023 the Trust hosted 'The Burdett Nursing Awards' to reward nurses for their sustained commitment to providing high-quality care. The aim of the awards was to recognise and reward teams of nurses who went above and beyond to deliver transformational and sustainable patient care, which has improved access to health and addressed its inequalities. £160,000 was awarded to the winning and shortlisted teams to spend on team training, education and professional development.



In 2021, the Nightingale Challenge, supported by the Trust, was relaunched as the Nursing Now Challenge which builds on the global movement to empower nurses and midwives as leaders, practitioners and advocates in health. The Nursing Now Challenge works with health employers as well as universities and colleges around the world to create leadership development opportunities for nurses and midwives.

In 2022, to mark the Trust's twentieth anniversary it launched The Burdett Fellows at the University of Edinburgh and King's College London. The Trust is proud to be extending this initiative to Wales and Northern Ireland in 2024. The scholarships will cover tuition fees and living expenses for postgraduate nursing students, providing them with the research resources for a career in nursing research, thereby developing research capacity and leadership within the nursing profession.

The Trustees and staff of Burdett Trust for Nursing are committed to the ethos and principles of equity, diversity and inclusion and we strive to put these into practice in every aspect of our work. We are committed to tackling all forms of injustice and we work to recognise and address the biases and stereotypes that counter opportunity.
