It's a place where you can hear rock legends or pop icons on the same night as folk trios or string quartets. Where new musicians are nurtured and showcased on the same stages as platinum-selling performers. And where youth choirs and tambourine-shaking toddlers practice in the same spaces as its acclaimed orchestra, Royal Northern Sinfonia.

Because as an international centre for music we're focused on creating and celebrating outstanding music – whether that's unearthing or growing talent from the region or bringing the world's best artists to our stages. And as a charity we're focused on making sure all of that is available to anyone – no matter where you're from, how old you are, how much money you have, or what challenges you face.

## Our Next Chapter

## Our next era puts music at the heart of our region and its culture.

#### It will involve:

- Royal Northern Sinfonia opening its most artistically ambitious chapter yet. This means vibrant community projects, searingly good performances, bonds with people and places across the region, international touring, and brave, ambitious leadership.
- New support for young artists, enabling the next generation of musicians from our region to thrive.
- Being a place where everyone can experience brilliant music whatever their financial means.
- Achieving net zero by 2030.
- Our region blossoming as a music hot spot, drawing in visitors, audiences, and artists.

We serve the North East region, and our base in Tyneside will be fully developed by 2027, creating a culture, education, business, and leisure destination on Gateshead Quays. Musicians from across the world perform on our stages, our orchestra tours internationally and we collaborate with international partners in our creative learning, artist development and performance programmes.

Since opening, over 1.7m young people have learnt music with us; we've run over 200,000 music classes for adults; and we've presented over 10,000 performances – to see all of them would mean catching a gig every day for 27 years.

The charity will be 20 in December 2024. It is young, still in growth and development mode and has a lot to offer the national and international music scene.

Our business model is diversified – with public funding, trading, philanthropy, and an endowment all contributing. The past few years have been tough financially, but we've had a huge amount of support through the pandemic. We're developing our financial model further to enable us to achieve our ambitions in coming years.

### **Our Board**

## Our Board is diverse, focused and passionate about the organisation's future.

It has 13 members, including two members from Gateshead Metropolitan Borough Council and two Young Trustees. Half the Board are based in the North East, half based across the UK reflecting the organisation's national and international as well as regional outlook. Terms are four years and members serve on one of four core committees: Finance and Audit, People, Trading Board and Programme. The Board meets four times a year, plus it holds an Away Day, in person. Committees meet each term online.

### **Our Next Chair**


As we begin our next chapter, we're looking for a new Chair who is ambitious for our region and for our organisation as an example of international excellence.

As Chair you would be supported by an experienced Vice Chair who is based in the region and by a group of Chairs of Board committees – you will have a team to work with. The Glasshouse has an experienced and committed leadership and management team who have navigated the pandemic and set up the charity's next chapter.





## The Role

## The role is stimulating and varied and involves leadership in these areas:

- Provide leadership and manage the Board of The Glasshouse
- Lead the Board's relationship with the Managing Director
- Oversee charitable governance responsibilities and monitor the organisation's performance

- Oversee good connections with musicians and the team
- Be visible and approachable in the world
- Be an ambassador and advocate for the organisation with a wide range of stakeholders
- Attend concerts and events and introduce others to The Glasshouse's activities
- Be active in the organisaton's fundraising and increase others' involvement
- Support the organisation's commercial development



### The Person

#### We think you will need a mix of these:

- Judgement, a long-term perspective and the ability to command respect in a wide range of contexts and stakeholders.
- Networks to support the charity's fundraising and income generation.
- Alignment with The Glasshouse purpose and values, including demonstrable commitment to ensuring the broadest possible range of people can experience music and achieving our 2030 net zero ambition.
- Bring a national perspective and profile to the charity.
- Confident leadership of a charitable board.

#### How it works

We would like to appoint a Chair for a four-year term from 1st January 2025, preceded by briefing, induction and a chance to get to know the organisation during the second half of 2024. The role is voluntary and unpaid with expenses covered.

We estimate that the time commitment for this role is three days per month with a lot of flexibility about when this time is given.
