### **About Ethos**

Ethos Foundation is a dynamic family foundation committed to contributing its assets to tackling child poverty in the UK. We have a bold ten-year mission—spending down our c.£60m endowment by the end of 2035, overseen by our Chair and founder Grant Gordon OBE. The Foundation is working to help to improve the systems surrounding children and families, with particular emphasis on early childhood. Ultimately, we want to close the gap in outcomes between children in poverty and their better-off peers, so that all children thrive.

We are seeking a committed and passionate individual to join our small Board of Trustees. As a Trustee, you will contribute to the foundation's strategic direction, help ensure good governance, and champion Ethos' work externally.

The Ethos Foundation vision is for a society where every child thrives, breaking cycles of poverty.

Our mission is to improve early childhood outcomes by uniting diverse partners, including communities.

# **Ethos Foundation Strategy**

Our goal is to help build more effective child poverty prevention systems, in order to break the cycles that cause further suffering throughout their lives. To do this:

- 1. We fund and enable holistic early years practice at community level
- We work in places with high levels of childhood poverty, implementing a collaborative service delivery model.
- 2. We help turn practice into policy
- We conduct and support research and analysis that builds the evidence base of what works in holistic early years practice.
- We use this research to influence policy and advocate for local and national level systems change.
- 3. We place **convening and coordination** at the heart of our work.
- We promote, facilitate and enable collaborative working at each level of the system: at service delivery level, funder level, network level, and policy level, by enabling collaboration between advocacy organisations and campaigners.
- 4. We build the skills and capacity required for a thriving ecosystem
- We build skills and capacity to work collaboratively and holistically, joining up services to more effectively meet families' needs.
- We help parents and communities to participate in decision making and service delivery.

We aim to be a progressive philanthropist using all the tools at our disposal to achieve impact.

### The role of a Trustee

Trustees play a pivotal role. As members of the Ethos Foundation Board, we are collectively responsible for:

- Governance & Strategy: Contribute to strategic planning and ensure the Ethos Foundation remains aligned with its mission.
- Financial and Legal Oversight: Annual budgeting and quarterly financial monitoring, ensuring transparency while managing risks. Ensuring compliance with legal and statutory requirements.
- Advocacy & Representation: Act as ambassadors, supporting Ethos' work, partnerships, and objectives.
- Board & Committees: Attend quarterly board meetings, contribute to decisionmaking, and participate in relevant committees.

This is an opportunity for a committed individual who shares our mission to help build more effective child poverty prevention systems, in order to break the cycles that cause further suffering throughout their lives.

We are currently a small Board (of 4) and staff team (of 2). Presently, we are developing our ten-year strategy to have the greatest impact during the Foundation's existence. The emerging strategic direction has identified that we would benefit from additional advisory and oversight capacity, as well as additional expertise in the areas of early childhood development; strategic communications and advocacy; and/or impact investment.

# Person specification

- Empathy and personal behaviour in alignment with Ethos's core values of fairness, good citizenship, and reflectiveness.

- Analytical skills to identify and assess risks and opportunities and take a balanced approach to both
- Experience in a strategic oversight role on non-profit Boards or Executive teams.

Understanding of strategic philanthropy, including grant-making and investing for social impact.

Relevant insight across one or more of following areas would be helpful:

- Early Childhood Development.
- Communications & Advocacy: expertise in public affairs, public relations, media, and/or strategic communications.
- Impact Investment: experience in social finance, or philanthropic approaches to market-building.

## **Terms of Appointment**

### Role requirements and time

**commitment:** Quarterly two-hour board meetings, with pre-reading and an annual Trustee away day. Participation in additional conference calls as needed, including any agreed sub-committee membership.

**Remuneration:** This is a volunteer position, but reasonable travel expenses can be reimbursed.

**Location:** Ethos Foundation is based in London, UK, with a preference for inperson Board meetings and annual away day. However, we have the option for some engagement to be remote.
